7.8.10: SUBDIVISION

THE DIVISION OF A PARCEL OF LAND IN THE FOLLOWING WAYS:

- (a) INTO ANY NUMBER OF LOTS FOR RESIDENTIAL PURPOSES WITH A NEW ROAD; OR
- (b) INTO ANY NUMBER OF LOTS FOR RESIDENTIAL PURPOSES WITHOUT A NEW ROAD IN ANY THREE (3) PERIOD, WHEN TWO OR MORE ARE LESS THAN TWO ACRES IN AREA.
- (c) NEW OR EXISTING ROADS MUST BE BUILT TO OR BROUGHT UP TO TOWN OF FREMONT SPECIFICATIONS (SEESECTION 4.2. ROAD LAYOUT, SUBDIVISION ORDINANCE)
- (D) BEYOND THIS, NEW YORK STATE HEALTH CODES REQUIREMENTS PUBLIC HEALTH LAW SECTION 1115 WILL ALSO BE MET.
