SECTION 1

THE INTENT OF THE TOWN BOARD OF THE TOWN OF FREMONT IS TO IMPLEMENT SECTION 328 OF THE REAL PROPERTY TAX LAW OF THE STATE OF NEW YORK PROVIDING FOR THE APPOINTMENT OF A SINGLE ASSESSOR, THEREBY ELIMINATING THE CURRENT METHOD WHEREBY THE TOWN HAS THREE ELECTED ASSESSORS.

SECTION 2

ON OR AFTER THE EFFECTIVE DATE OF THIS LAW, THE TOWN OF FREMONT SHALL HAVE BUT ONE ASSESSOR, TO BE APPOINTED AS PROVIDED IN SECTION 310 OF THE REAL PROPERTY TAX LAW.

SECTION 3

THE TERM OF THE SOLE APPOINTED ASSESSOR SHALL BE SIX YEARS COMMENCING ON OCTOBER 1, 1997.

SECTION 4

THE TOWN BOARD FOR THE TOWN OF FREMONT HEREBY DETERMINE THAT THE WITHIN LOCAL LAW SHALL BE SUBJECT TO A PERMISSIVE REFERENDUM PURSUANT TO SECTION 24 OF THE MUNICIPAL HOME RULE LAW.

SECTION 5

THIS LOCAL LAW SHALL TAKE EFFECT IMMEDIATELY UPON FILING WITH THE SECRETARY OF STATE PROVIDED, HOWEVER, THAT SUCH LOCAL LAW IS SUBJECT TO A PERMISSIVE REFERENDUM AND THE TOWN CLERK SHALL FORTHWITH PROCEED TO NOTICE SUCH FACT, CONDUCT SUCH REFERENDUM IF REQUIRED BY PETITION.
