Date Board of Assessment Review Meets

An Amendment to Local Law # 1-1998

A Local Law establishing the fourth Wednesday in May after the fourth Tuesday of May as the annual date for the meeting of the Board of Assessment Review to hear complaints in relation to assessments.

WHEREAS, the Town of Fremont currently employs an Assessor who is at the same time employed by another assessing unit, and

WHEREAS, the Town of Fremont wishes to establish a date for the meeting of the Board of Assessment Review other than that provided in Subdivision 1 of Section 512 of the Real Property Tax Law,

NOW, THEREFORE, be it resolved that the date on which the Board of Assessment Review for the Town of Fremont shall meet to hear complaints in relation to assessments shall be the fourth Wednesday in May after the fourth Tuesday in May of each and every year hereafter beginning May of 1998.

This Local Law shall take effect immediately upon the filing with the Clerk of the Town of Fremont and with the State Board of Assessment and Review and Office of the Secretary of State.
